

**2022 LOOKOUT PASS EAGLE PEAK SNOWCAT SKIING ADVENTURES
RELEASE - EXPRESS ASSUMPTION OF RISK
READ CAREFULLY – IMPORTANT INFORMATION**

Skiing is an inherently risky activity that involves certain unavoidable hazards even within the boundaries of a regularly maintained ski area. Snowcat skiing, which by its very nature takes place primarily outside of regularly maintained ski area boundaries (and therefore outside of Lookout Pass Ski Areas maintenance and grooming activities), is an inherently dangerous activity, and **all participants in this program must agree to acknowledge and expressly assume all risk of personal injury or loss or damage to property that may occur as a result of the inherent risks and dangers of snowcat skiing.**

A participant will almost always encounter variations in snow conditions, along with unmarked bumps, drifts, rocks, stumps, forest growth, brush, drop offs and other obstacles or hazards, including other skiers and snowmobiles, which may be utilizing the snowcat skiing area in addition to the Lookout Pass Eagle Peak Snowcat Skiing Adventures program. There is always the possibility of avalanches. Further, Participant is aware that injury-causing falls may occur. These risks can be reduced but not eliminated by following proper procedures and heeding the directions of the person who gives the mornings orientation, and all Patrol or snowcat drivers directives.

Participant agrees to defend and indemnify Lookout Pass Associates, LLC doing business as Lookout Pass Ski and Recreation Area, and its employees, agents, successors, and assigns, from all claims for property damage, injury or death arising out of participation in the Lookout Pass Snowcat Skiing adventures program, which (1) he/she may suffer or for which (2) he/she may be liable to others or for (3) Participant's conduct that may contribute to a claim being asserted against Lookout Pass Ski and Recreation Area whether such claims are for negligence or any other theory of recovery, except for intentional misconduct.

In consideration of being permitted to participate in the Lookout Pass Snowcat Skiing Adventures program, the undersigned Participant, or Participant's spouse, legal representatives, heirs and assigns, **herby acknowledges and expressly assumes the risks** of Lookout Pass Snowcat Skiing Adventures program. Participant also releases all rights and claims for any photographs taken by Lookout Pass Associates, LLC doing business as Lookout Pass Ski and Recreation Area.

Participant hereby expressly assumes full responsibility for the risk of bodily injury, death or property damage while participating in the Lookout Pass Snowcat Skiing Adventures program.

Participant expressly agrees that this express assumption of risk and defense/indemnity agreement is intended to be as broad and inclusive as permitted by the State of Idaho, and that if any portion hereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
