I am aware and understand that participation in this lesson or activity may result in serious injury, death, or property damage and I accept such risk on behalf of myself and my child. Governing law shall be according to the laws of the State of Idaho and any action shall be filed in Idaho District Court, County of Shoshone, or U.S. District Court for the District of Idaho.

My child and I agree to RELEASE Lookout from any and all liability and/or claims for property damage, injury or death arising from my participation in ski lessons, including those claims based on Lookout's alleged or actual NEGLIGENCE. Further, my child and I agree to WAIVE my right to file a lawsuit against Lookout for **any existing or future claims**. Additionally, my child and I agree to DEFEND and INDEMNIFY Lookout from all claims for property damage, injury or death arising out of our participation in ski lessons, which (1) we may suffer or for which (2) we may be liable to others or for (3) our conduct that may contribute to a claim being asserted against Lookout.
