RELEASE OF LIABILITY

Governing law and venue shall be according to the laws of the State of Idaho and any action shall be interpreted in Idaho District Court, County of Shoshone, or U.S. District Court for the District of Idaho.

Acknowledgment of Personal Information & Equipment Instructions

I have accurately represented the above listed information and it is true and correct. I will not use any of the equipment provided to me during this transaction until I have received instruction on its use and I fully understand its use and function. I agree to verify that the visual indicator settings to be recorded on this form for downhill ski equipment - agree with the number appearing in the visual indicator windows of the equipment to be listed on this form.

I accept for use as is the equipment listed on this form, and accept full financial responsibility for the care of the equipment while it is in my possession. I will be responsible for the replacement at full value of any equipment rented under this form, but not returned to the rental facility. I agree to return all rental equipment by the agreed date. I understand that equipment insurance, for an additional fee, applies to equipment breakage only; not lost, misplaced, or stolen equipment. If the equipment insurance is accepted, the rental shop will absorb the cost of replacement of any damaged equipment. Any lost or stolen equipment shall be replaced or compensated for by the customer. I understand that the binding system cannot guarantee the users safety. In downhill skiing, the binding system will not release at all times or under all circumstances where release may prevent injury or death, nor is it possible to predict every situation in which it will release. In snowboarding, cross-country, skiing, ski boarding, snowshoeing and other sports utilizing equipment with non-release bindings, the binding system will not ordinarily release during use; these bindings are not designed to release as a result of forces generated during ordinary operation.

I understand that the sports of skiing, snowboarding, snowshoeing and other sports (collectively "RECREATIONAL SNOW SPORTS") involve inherent and other risks of injury and death. I voluntarily agree to expressly assume all risks of injury or death that may result from these RECREATIONAL SNOW SPORTS, or which relate in any way to the use of this equipment. I understand that a helmet designed for RECREATIONAL SNOW SPORTS use will help reduce the risk of some types of injuries to the user. I recognize that serious injury or death can result from both low and high energy impacts, even when a helmet is worn.

I agree to hold harmless and indemnify Lookout Pass Ski and Recreation Area, as well as its owners, members, agents, assigns, the binding manufacturer, and employees for any loss or damage, including any that results from claims for personal injury or property damage related in any way to the use of this equipment (except reasonable wear and tear of the equipment itself). I hereby agree to accept the terms and conditions of this contract. This document constitutes the final and entire agreement between this ski area and the undersigned. There are no warranties, expressed or implied, which extend beyond the description of the equipment listed on this agreement, and this equipment is accepted by myself, "AS IS".

Governing law and venue shall be according to the laws of the State of Idaho and any action shall be interpreted in Idaho District Court, County of Shoshone, or US district Court for the District of Idaho.

I have carefully read this agreement and fully understand the release of liability provisions it contains. I am aware that this is a "Release of Liability" contract between myself, this ski area, and the binding manufacturer; and, I sign it of my own free will.
